







Dear participants, coaches and attendants,

we are glad that we are able and allowed to host the Westerstede Horse Trials once again this year.

Unfortunately, due to Covid-19, we still have to accept restrictions and follow additional rules.

The "Corona Ordinance" of Lower Saxony is authoritative and binding.

Currently, the infection rate is low here and we hope it will stay like that.

A part of our hygiene concept includes that not all the stables are on the show grounds. We have tried to set up the other stable tents no more than 5 km away.

In addition, due to the high number of entries, we had to adjust the schedule to allow as many riders as possible to participate. We thank you for your understanding.

The following rules must be followed during our competition:

- A negative Corona test not older than 24 h for the participants/ attendants from Germany has to be shown.
- Free rapid tests can be made at the Corona Test Centers Ammerland after prior registration under: <a href="https://www.ammerlandtest.de">www.ammerlandtest.de</a>
- Foreign riders/ attendants have to show a negative PCR test not older than 72 h.
- Excluded are recovered and vaccinated persons (2nd vaccination older than 14 days), riders up to 18 years as well as attendants up to 15 years.
- The proof of attendance must be either filled out and submitted (available at <a href="www.rechenstelle.de">www.rechenstelle.de</a>) or by checking in with the App "Luca".
- One attendant is allowed per rider; one groom is allowed per 2 horses.
- No entry with known Covid-19 symptoms. If symptoms occur during the event, a doctor must be contacted to avoid any risk.
- Masks are mandatory on the show grounds, in the stable tents and in the parking lots. Only medical masks and FFP2 masks are allowed.
- Disinfectant dispensers are sufficiently available and have to be used regularly.
- Riders do not have to wear masks while riding.
- The distance rules (min. 1.5 m) must be followed. Social gatherings and crowds are prohibited.
- Please do not enter the private riding facilities and stay behind the barriers.
- Please respect the one-way street Schlossweg
- Access only with entrance bands.
- Award ceremonies will not take place.
- Horse passports will be given out when returning back numbers.

At the moment the departure has to be registered in the FEI App due to the herpes virus. If there are any news about it, we will inform you.

ARRIVAL FOR PARTICIPANTS WHO ONLY RIDE CROSS-COUNTRY (YOUNG HORSES) AND NO INTERNATIONAL COMPETITION:

- Directly drive to Schlossweg 27, 26655 Westerstede.
- A negative Corona test not older than 24 h must be shown for the participants/ attendants.
- The proof of attendance must be either filled out and submitted (available at <a href="www.rechenstelle.de">www.rechenstelle.de</a>) or by checking in with the App "Luca".
- There you will receive the entrance bands.
